- | <p>1. All writing should be in ink or typewritten. Do not use pencil.</p> <p>2. Give sex and Animal ID number.</p> <p>3. Give name and ABBA number.</p> <p>4. Give name of buyer and complete address.</p> <p>5. Give exact date of delivery. (This is important for registration of subsequent progeny.)</p> <p>6. If the animal being transferred is a female and was bred prior to the date of delivery and had not then calved, the name, ID number and ABBA Registration number of the service bull and date of service or period of exposure should be given. The owner of the service bull MUST place his signature in the lower left corner of the transfer application. Be sure to state if service was by A.I.</p> <p>7. If a female being transferred is not bred at date of delivery, the words "Not Served" should be written in the service space.</p> | <p>8.
