# **TRANSFERS**

## TRANSFER OF OWNERSHIP

Every change in ownership must be promptly recorded with the American Brahman Breeders Association, in order that progeny of the animal may be registered and subsequent changes in ownership are recorded. Open transfers are condemned and considered a poor practice. Be proud of your product and promptly submit completed applications for transfer of ownership once you have sold an animal. Applications for Transfer must be submitted to the ABBA office immediately after the sale transaction is completed.

## **REQUIRED INFORMATION (Backside of original registration certificate)**

- a) Name and address of buyer and ABBA membership number (if known).
- b) Seller, ABBA membership number and signature.
- c) Date of delivery (month, day, year). The sale date is not so important as the date on which the animal actually leaves the seller's ranch and is delivered to that of the new owner. This exact date of delivery is important for future reference concerning breeding information.
- d) Mark clearly where to send the new registration certificate in the space provided (to the buyer or seller). If neither box is marked, the new certificate will be sent to the buyer.
- e) If a female being sold has been bred, A.I.'s and/or exposed, this information should be entered in the appropriate place I this section.
- f) Calf-at-side: if a cow is sold with an unregistered (less than 365 days) calf at side, the seller must provide the private herd number (PH number) and ABBA number of the service sire as well as the sex and date of birth of the calf. If the seller is not the owner of the service sire, the signature of the owner of the service sire is required.

## TRANSFER BY PARTNERS OR PARTNERSHIPS

In case partners of a partnership desire to change ownership of their animals from one partner to the other, they may do so by paying \$5.00 on each animal, or in case partnerships are formed, animals may be transferred from the original owner to the new firm at \$5.00 each. The legal time limit for settling or closing of the business of an estate will be recognized by the Association.

In case of transfers of animals owned by a partnership, transfers will be made upon submission to the Association of transfers duly executed by all persons interested in the partnership. The Association nevertheless reserves the right to require other and further evidence with reference to any such transfer.

### PENALTY FOR FAILURE TO TRANSFER ANIMAL

Any member of the Association who sells a Brahman animal(s) and represents them to be registered or eligible for registration in the Herd Register of the American Brahman Breeders Association, and who shall refuse to furnish a bona fide registration certificate and proper transfer to purchaser within ninety days after said sale and within thirty days after having been requested to do so by the President of the Association in written request sent by registered mail, shall automatically be suspended from membership in the Association.

### PROFORMA TRANSFER OF OWNERSHIP

In case of the disappearance or the persistent neglect or unreasonable refusal of the seller to give a certificate of transfer of ownership, the record of such transfer may be made by the Recording Secretary upon approval of the Board of Directors on satisfactory evidence of the sale and delivery of the animal.
